“Through this acquisition, it has been our intention to raise the profile of *Transactions of the Canadian Society for Mechanical Engineering* and highlight its value for the Canadian mechanical engineering community as well as the international community of mechanical engineers,” said the President of the CSME, Dr. Sushanta Mitra. “The society has been proud to oversee this journal for the last 45 years and for this next step in the journal’s history we are pleased to partner with CSP and excited to witness the journal continue to grow and develop,” continues Dr. Mitra. “With this acquisition, we are also proud to continue to officially call the *Transactions of the Canadian Society for Mechanical Engineering* CSME’s official technical journal. This is an excellent achievement as we celebrate Canada’s 150th birthday and inch closer to CSME’s 50th anniversary in 2020.”

Transactions of the Canadian Society for Mechanical Engineering is a peer-reviewed journal that has been published quarterly since 1972. *Transactions of the Canadian Society for Mechanical Engineering* is dedicated to the broad field of mechanical engineering. As part of this acquisition, the Executive Editor-in-Chief of CSP and the CSME will work together to develop an updated journal scope and expand the journal’s editorial board to reflect the core and emerging areas of mechanical engineering.
